## Tour Itinerary

### FRIDAY, SEPTEMBER 30 – ARRIVAL DAY

Check into the Hotel Chaco and meet SET staff to pick up souvenirs and on-site travel documents. Gather together for an evening welcome reception with a hot air balloon industry guest, including light hors d'oeuvres and drinks.

### SATURDAY, OCTOBER 1

Early morning departure for Balloon Fiesta Park for Dawn Patrol and Mass Ascension. Mid-morning return to Old Town. Afternoon at leisure. Late-afternoon return to Balloon Fiesta Park for the evening Twilight Twinkle Glow. Access to Chasers' Club hospitality (food and drink) available for both sessions. Musical performances, attractions, concessions and shops are located around the park.

### SUNDAY, OCTOBER 2

Return to Balloon Fiesta Park early morning to continue exploring all the park has to offer. From the vibrant balloon-filled skies to a behind-the-scenes look at balloon operations at the Balloon Discovery Center, there is something for everyone! In the evening, revel in an Albuquerque tradition—a Flamenco dinner at Tablao, featuring a time-honored tapas experience.

### MONDAY, OCTOBER 3 – DEPARTURE DAY

After breakfast, check out of the Hotel Chaco, and have a safe trip home!

### OPTIONAL POST-TOUR: Sante Fe (October 3-5, 2022)

After the main program ends, take a group transfer from Albuquerque to Santa Fe, where you'll enjoy two nights accommodations at Eldorado Hotel & Spa with breakfast daily. Set out on a guided afternoon tour in Chimayo with admission to El Santuario de Chimayo, the Chimayo Museum, and lunch. Delight in a behind-the-scenes tour of Georgia O'Keeffe's Home Studio and admission to the Georgia O'Keeffe Museum. On the final day, take a group transfer to Albuquerque International Sunport airport for flights home.

**Reservations & Payments** Reservations may be made online, by phone or by mail. Deposits and/or final payment may be made by Visa, MasterCard, American Express, Discover or Check. Please make check payable to Sports & Entertainment Travel, LLC. The deposit will equal roughly 25% of the reservation total and is noted above. The final balance of your payment will be due 60 days prior to the trip. The credit card used to make the reservation will be automatically charged 60 days out unless notified otherwise. If final payment is not received by Sports & Entertainment Travel, LLC by the final payment due date, Sports & Entertainment Travel, LLC may, at any time and with or without notice, cancel your reservation in its sole discretion with no right of refund. Travel packages booked within 60 days of the package start date will require full payment upon booking and are nonrefundable.

**Cancellations, Refunds and Changes** Cancellations made more than 60 days prior to travel will result in a loss of the tour deposit. No refunds will be issued after the final payment due date, unless the participant's airline and/or hotel space is resold. If space is resold, participant will receive a full refund excluding a 20% cancellation fee and any corresponding hotel or airline fees – up to \$200 per person. Any cancellation request must be made by guests to Sports & Entertainment Travel, LLC in writing prior to cancellation fulfillment. Any name changes or changes to package arrangements made after registration are subject to an additional convenience fee. No name changes will be accepted within one week of travel.
